**Subject:** Part III from Sharon K re: SLAPP fixing for HHS policy deformers

Ms. AhMoi Kim was the executive secretary of the California Commission on Judicial Appointments (COJA) in 2017. She was also CANTIL-SAKAYUE'S executive secretary.

On February 3, 2017 she gave Secretary Becerra forty-five pages of documents that I wrote and compiled explaining why I was objecting to DATO's appellate appointment on behalf of People, science, justice, and myself.

In addition to listening to me explain the crime orally at the February 9, 2017 COJA hearing; I know that Secretary Becerra also read of the crime involving HHS, and thus has superior knowledge.

This is because he was charged to read the documents that Ms. Kim gave him, as a vetting-before-voting COJA panelist.

The below jpeg is from those documents explaining that "IT" (the crime against humanity) is caused by a racket and a cover up with multiple misuses of government assets -- now under Secretary Becerra's stewardship of HHS with junk science of the SLAPP plaintiffs remaining viable in policies.

"TMD" stands for People disabled by biotoxins (lay terminology "toxic mold") in water damaged buildings.

They are toxicologists with PhDs who rely on the scientifically void Veritox Theory as Toxic Mold expert defense witnesses for the DOJ, insurers and others. It is a cost shifting scheme funded by the DHHS & EPA to be included in US physician educational materials to aid the avoidance of financial responsibility for causation of disability and death from "Toxic Mold". **WHAT WAS**

**SAID AT THE COJA HEARING.**

Below is some of what was said at the February 9, 2017 COJA hearing. I have the video clips to corroborate, but do not want my emails to you to get kicked back. Will send upon request.

These are the words said showing how Secretary Becerra came to own -- what is to the best of my knowledge -- one of the largest ongoing rackets and cover ups ever to occur in the history of environmental medicine at HHS and the California courts via making "*harmless error*" jokes about it with California jurists.

On February 9, 2017, he said:

***If you'll allow me to interject for Mrs. Kramer's sake, that the department of justice is there, available. If she has some matter she'd like to bring to the attention of my office, we'll certainly consider that. We always will. We always should.***

I knew that the above quoted words were placatingly disingenuous as soon as they rolled from his lips. This is because he turned around and in the next breath, sold doubt about everything I said with bad jokes. Then, without even asking me one question, voted to appoint a judge who he just pledged to investigate for SLAPP fixing, for and with HHS policy deformers as plaintiffs, to be an appellate justice. He said:

***But your [DATO's] stock went up when Judge Pressman said you eat cheap tacos... So I think Judge Pressman was talking to us when he talked of harmless errors. And so, Madam Chief Justice, my questions are very few. [NONE].***

***Because I suspect we're in a room of extremely harmless errors and we look forward to elevating Judge Dato to the Fourth... Aye.***

## **ORIGIN OF THE DEADLY BAD JOKE**

Below is the origin of bad joke that was parroted by the current HHS Secretary, while selling doubt that I am a woman who tells the truth and while taking ownership of IT.

On February 9, 2017, prior to when I spoke against the appellate appointment of San Diego Superior Court Judge William DATO, his good friend and fellow SLAPP fixer San Diego Superior Court Judge Joel PRESSMAN spoke in favor of the appointment.

PRESSMAN told a funny story about a time that they both had difficult cases and they were afraid that unreasonably disgruntled litigants were going to shoot arrows through their office window. The he cleverly ended his presentation with:

***I'm proud to call Bill Dato my friend. And I'll conclude with these words that I trust you will remember, harmless error.***

The room filled with California judges and justices roared at the “*harmless error*” joke. I did not laugh. I got that I was the butt of the joke. PRESSMAN was painting me as an ignorant disgruntled litigant and selling doubt that I was going to the truth about the willful judicial SLAPP fixing, before I even said one word.

The joke became even more mean spirited and less funny. California Chief Justice Tani CANTIL-SAKAYUE joined in with the doubt selling fun. She said:

***Wise words, Judge Pressman. Wise words.***

Again the room roared. I rolled my eyes. CANTIL-SAKAYUE has known of the SLAPP fixing to defraud the public, since September of 2011.

I was found in civil contempt of court in 2012 because website owners refused to remove the evidence of her and others' knowledge of IT from their sites. So then it was decided that I had to sign a document stating “*I do not believe Dr. Kelman committed perjury*” or go to jail in March of 2012, for alleged civil contempt of court.

Nothing short of killing me would cause me to go silent. I was not going to agree to deem myself a liar by signing a fraudulent document under penalty of perjury. I went to jail because no one would intercede to stop the retaliatory judicial SLAPP fixing, for and with, HHS policy deformers.

The evidence that 2017 COJA panelist CANTIL-SAKAYUE, has known of the SLAPP fixing since 2011 including KELMAN's perjury while strategically litigating, was in the documents that Ms. Kim gave Secretary Becerra to use for vetting of DATO on February 9, 2017.

## **WHAT I TOLD SECRETARY BECERRA AT THE COJA HEARING & MY "YES" or "NO" QUESTION.**

I said:

I have a degree in marketing and am a medical journal published author regarding misconduct when setting policies over disabilities caused by water damaged buildings.

I'm one of the people who worked very hard to cause the CJP [Commission on Judicial Performance] audit because of court crimes going unpunished.

I object to Judge Dato's appointment to the Fourth/First because of honest services fraud with Judge Pressman, Justice McConnell, Justice Huffman, Justice Benke, Justice Irion [Justice Aaron] and several San Diego San Diego judges and clerks.

I submitted documents. See exhibit five for Judge Pressman's use of a void judgment.

The crime in which Judge Dato is unfortunately involved is this: There's a scientifically void risk assessment model. It's called the Veritox Theory. It was penned by toxicologists at Veritox, Inc. [HHS toxicologist Bryan D. Hardin, Ph.D. & his business partner toxicologist Bruce Kelman, Ph.D.]

What it does is falsely claim to prove that toxic mold can never reach a level to disable or kill.

In 2005, I published a writing. It exposed how the Veritox Theory was being mass marketed into policies by joined unclean hands of the U.S. Chamber of Commerce, a think tank, a U.S. congressman, a medical association, and the owners of Veritox, Inc. who are toxic tort expert defense witnesses for the United States Department of Justice, other government agencies, and insurers.

Veritox relies on fraud remaining in policies to lend undue credibility to their bogus testimonies when serving as toxic, um, basically cheating toxic mold disabled people in litigation and in claims handling practices.

In 2005, Veritox and their president, Bruce Kelman, sued me for libel for the words “altered his under-oath statements” in the writing.

## MY BIOGRAPHY

My biography as it relates to this matter is in the below indented paragraphs. It was written in October of 2020. This is months before I knew that California Attorney General Xavier Becerra would soon be joining his fellow former California Attorney General Kamala Harris in the White House Cabinet as appointed HHS Secretary. It states:

**Mrs. Sharon Noonan Kramer** holds a degree in marketing from the University of Mississippi, 1977. She uses her marketing skills to communicate concerns to government regarding integrity in the intertwined subjects of environmental science, medicine, policy, and accountability in the courts. She is a medical journal published author on the subject.

Over the years she has collaborated with numerous non-profit organizations and individuals to effectively bring changes in federal and state policies and practices. This includes mildly improved disciplinary oversight of California's judges by the Commission on Judicial Performance in 2019; and a federal audit detailing the need for consistent and accurate federal messaging about the health effects of mold and moldy buildings.
